Limited slip martingale collars are allowed. Single piece slip collars/leads are allowed. Harnesses, with the exception of head-halter types, are allowed. Dogs MUST run "naked," without a collar/harness. Collars/harnesses, which can be easily and quickly removed and replaced, are strongly encouraged. NO flexi-leads allowed.
